Update on Grant Proposal

The proposal "Social Networks and Archival Context Cooperative: Pilot Phase II" was formally submitted on July 7. The Mellon Foundation Board will meet on September 11, and their decision will be made by the end of the day.

The next step will be to invite the other Chairs of the Working Groups to evaluate and comment on the Portal. An ideal timeline is to have the Portal ready in time for the September in person meeting in Washington, DC.

The main concerns identified were

- To define the purpose of the Portal (vs. Google Docs) in order to clarify what is needed.

- And functionality for documentation/content that is included (particularly in terms of dynamism and file types).

Reporting from the annual meeting of the Society of American Archivists in Portland, Oregon

The SNACSchool Working Group is excited to report that the first official SNACSchool event was a complete success. Thanks are due to so many for helping SNACSchool happen in Portland during the Society of American Archivists week. The Working Group would like to thank our kind host, Cristing Pachild, who helped us secure a classroom in the Millar Library on the beautiful campus of Portland State University for the day-long event. Thanks are also due to our “friend in Portland” Terry Baxter, archivist at the Multnomah County Archives, for his assistance in connecting us with Cris and PSU.

SNACSchool was realized both as an in-person experience, and as a remote experience for twenty students. The class was made up of current SNAC members and several soon-to-be members, including representatives of the Walt Whitman Archives, University of North Carolina-Chapel Hill, the Mojave Desert Archives, Utah State Archives and Records Service, Portland State University Library and the Oregon Historical Society. Without a hitch, SNACSchool instructors moved through the five training modules ... SNAC101, Introduction to Archival Authority Control, User Accounts and Profiles, Searching in SNAC, and Creating/Editing SNAC records. Instruction involved lecture presentations as well as live demonstrations in SNAC-dev. By the end of the day, all students had an opportunity to create and edit their own SNAC records, then send the new identity constellations through the review process.

Finally, special thanks to members of the SNACSchool Working Group: Glen Wiley, Dina Herbert, Barbara Aikens, Melanie Yolles and Alan Mark, for their collaboration in development of the SNACSchool curriculum. And finally, very special thanks to Dina and Glen for their work as instructors in the SNACSchool classroom. Their support is invaluable!

In addition to SNACSchool, NARA's SNAC Liaisons hosted a SNAC information table in the SAA registration hall. We welcomed many interested folks for information sharing and SNAC demonstrations. A special thanks to SNAC partner Michael Rush (Yale) for joining us at the table to help with SNAC demonstrations.

We look forward to hosting many more of our SNAC partners in our next SNACSchool event during the upcoming SNAC Partners' meeting at the National Archives Innovation Hub on September 27 and 28.
